### Conditions for Duty Exemption of Liquors for Vinexpo Hong Kong 2018 (29-31 May 2018)

Dear Exhibitors / Agents,

Vinexpo and W&S Logistics in cooperation with our HK partner FLYNT INTERNATIONAL are applying to Hong Kong Customs for a special exemption of duties and taxes on liquors/spirits (>30% alcohol content) imported for VINEXPO HONG KONG 2018. As Vinexpo authorized agent Flynt shall assume the legal liability under the Dutiable Commodities Ordinance Cap 109, Laws of Hong Kong, for any sale, missing, damage, theft, etc. In this regard, Flynt shall only execute the application of the duty exemption upon receipt of your signed acceptance of all the conditions and procedures set out below.

# Please review the conditions below carefully as Hong Kong Customs has implemented new procedures since the previous Vinexpo

### Conditions as requested by Hong Kong Custom

- Full duty shall be paid by exhibitors or handling agents for any duty-exempted liquors that are found being sold, missing, broken or stolen after the release of them to exhibitors upon importation.
- Before the opening of the exhibition, which is scheduled for 29 May 2018, all the duty-exempted liquors shall be delivered to the exhibition venue where Flynt /W&S Logistics shall mark legibly and permanently "SAMPLE NOT FOR SALE 樣本-不得售賣" on the front of the liquor bottles as per photo "A"
- Before the opening of the exhibition, which is scheduled for 29 May 2018, all the duty-exempted liquors shall be delivered to the exhibition venue where Flynt shall remove the foil wrap or capsule on the top of each liquor bottle as per <u>photo "B"</u> (this is a new requirement)
- All the exhibitors with duty-exempted liquors shall agree to be strictly controlled by following control measures during the exhibition periods:
  - Shall not deliver any duty-exempted liquors to the local market for sale before, during or after the exhibition
  - $\circ$  Shall inform Flynt of the total quantity of the liquors used for free tasting and for giving away
  - Shall not allow to bring any same type and years duty liquors during the exhibition which will be suspicious during custom on-site inspection
  - Shall not allow to display any FAKE liquors during the exhibition

- Liquors shall be kept in specified booth, any movement within exhibition halls shall be informed Flynt in advance
- Shall return the remaining stock of any duty-exempted liquors to Flynt after the closing of the exhibition for:
  - Destruction
  - Duty payment
  - Export
  - Disposal in any other way as approved by Custom

#### Procedures:

- Pack all the liquors / spirits bottles separately from other goods (wine and dry goods)
- Issue a separate invoice /packing list (Appendix 4) for liquor / spirits and indicate the <u>real market</u> <u>value.</u>
- /!\ THE CIF PRICE OF ONE BOTTLE OF 0.75 L COULD NOT BE LESS THAT 10 EUROS /!\
- <u>/!\</u>HKG Custom adjust the value of imported liquors/spirits if it's under estimated, and charge you the penalty fees. <u>/!\</u>
- Ensure correct liquors/spirits information in packing list
- Ensure correct shipping mark on each carton correspond with the packing list information inclusive Booth Number, Carton Reference (match the line with the packing list) and exhibitor name
- If there are any discrepancy in packing list and shipping mark in locating the liquor/spirit, an handling charge of HK\$20 per item will be charged.
- Send this documentation to FLYNT/ W&S Logistics 10 days before loading the goods by air or by sea, or 2 days before the delivery to W&S or its agents' warehouses.
- A charge of HK\$3 per bottle for the duty exemption mark and remove the foil wrap or capsule of each liquor bottle as per Custom Condition
- Pay a deposit to **W&S Logistics or Flynt** (100% of spirits value) to guarantee the respect of the procedure required by customs.
- The last day of the show, W&S LOGISTICS / FLYNT will ask all concerned exhibitors to complete and sign a sworn statement declaring that that no liquor were sold and the quantities that were consumed/given away.
- Deposit will be refunded (less 20% for management fees) after exemption is approved by customs at the closure of the exhibition.
